The Church of Scientology were hosting an event over the weekend in which they were anticipating significant numbers of attendees. The protestors made their way to the location from EAST GRINSTEAD TOWN CENTRE at around 1430. I do not recall the number of people within the group or the exact time they arrived at SAINT HILL ROAD. Police facilitated their journey when they reached SAINT HILL ROAD, due to a lack of footpaths and the protestors needing to walk on the road. The group were escorted by police to a location at the side of the road a short distance from the entrance to the Church of Scientology premises. The Church of Scientology had numerous security staff working, some of whom were stationed at the entrance and lining the boundary of their premises behind where the protestors decided to stand. Police monitored the group for a few hours, who remained at the side of the road. One of the attendees had a loud hailer and other members of the group had banners and placards. I do not recall what was written on them. The protestors did not cause obstructions to the road, except for during the time they were escorted to and from their protest location. There were traffic issues caused by the number of people attending the Scientology event and the traffic was heavily backlogged on and around SAINT HILL ROAD,		Protestors marched from East Grinstead Town Centre to St Hill Road where the Police facilitated their journey as there are no available footpaths and protestors required to walk on the road.
