Are you aware of the Church of Scientology event at Saint Hill Manor due to be held between the 3-5 November?

I visited the location today (16/10) as we had a complaint that the event was not going to be held in compliance with their Premises Licence

They are expecting around 6000 people in attendance on each of the days.

I spoke with Janet Laveau on site, email [REDACTED]

She appears to be the organiser of this particular event. She did say that you had been advised previously of the event and that she has a meeting with Insp Dave Derrick soon with regards to potential protest activity at the site. I have asked that they complete the event notification if not already done so. They do have a EMSP which I have also asked to be forwarded either to myself or direct to you.
