

RESPONSE OF CHURCH OF SCIENTOLOGY TO PREMISES LICENCE REVIEW

INTRODUCTION

This is the response of the Church of Scientology Religious Education College Inc ("the Church") to an application to review its Premises Licence made by Mr Alexander Barnes-Ross on 10 December 2025 (ref: LI/25/1895) for its property at Saint Hill Manor, Saint Hill Road, East Grinstead RH19 4JY.

The Church of Scientology has been present in East Grinstead since Saint Hill Manor was purchased by the founder of the religion, L. Ron Hubbard in 1959. Subsequently the estate was transferred to the Church. The largest Scientology Church in the United Kingdom was built on the grounds of the estate, a building known as Saint Hill Castle. This Church is a registered public place of religious worship, and thousands of Scientologists from around the world come to it each year to practice their religion. The Church also holds a number of substantial community and family events in the Church and the Saint Hill grounds over the course of the year, which are very popular with local people, with thousands attending. The International Association of Scientologists (IAS) Annual Anniversary Event is also held at Saint Hill over three days in October each year – attended by Scientologists from around the world, which concludes with a Charity Concert also attended by many local people.

The current Premises License was granted in 2009 and has been amended several times since. The licence provides requirements to notify the relevant health and safety authority with details of events and activities, submit a noise management plan and, for larger events, complete full risk assessments, be in full liaison with Sussex police and appoint professional childcare. The Church complies fully with these requirements.

The only licensable activity that occurs at Saint Hill is the provision of regulated entertainment. As the provision of entertainment incidental to a religious meeting or service, or at a place of public religious worship, is specifically exempted from being regulated entertainment – there is in fact very little that occurs at Saint Hill which is a licensable activity. Much of the activity which occurs during the 3 days of the IAS event is not a licensable activity. The Charity Concert, held on the Sunday night, clearly is.

Similarly, while the Church holds several community events throughout the year, most do not involve licensable activity because they do not involve selling alcohol, providing regulated entertainment or supplying late-night refreshments.

The Designated Premises Supervisor for the last 10 years has been Colin Dyer, who is a British citizen.

At the outset I feel it prudent and relevant to provide a brief background so as to understand why this application for a review has been made by Mr Barnes-Ross. Mr Barnes-Ross lives in London, many miles away and hence he is not part of the local

community nor personally involved in any local activities. He has never attended any event or function at the Saint Hill property - beyond when he organises protests at the IAS Event. He has made it clear over the past three years that he is motivated by animus towards the Scientology religion. He has also publicly stated since he began filing complaints with authorities that his intent is to incommode the Church as much as he can.

After filing what proved to be a purely vexatious complaint with Mid Sussex Planning Enforcement, on 4 December 2023 he announced:

"I'm not just doing this as a one-off thing. I'm gonna continually, you know, keep poking."

In this complaint he asserted, that a new building at Saint Hill may not have been built in accordance with its planning permission. This was investigated by the Enforcement Officer who measured it and confirmed the building had been constructed in accordance with the approved planning documents. This wasted a great deal of time and money for both the Church and the Council, in investigating this nuisance claim.

He has posted hundreds of videos on his anti-Scientology YouTube channel, many where his repeated refrain is:

"I'm on war-footing and I'm not f---king about".

While protesting at the IAS Event this past year, on the 3rd day Mr Barnes-Ross said on his live stream:

"If only someone would call the Council to report the noise nuisance which nobody appears to be willing to do".

As part of his ongoing campaign, he has run social media campaigns targeting local and Mid Sussex Councillors as well as local charities for engaging with the Church on charity events causing a great of harassment. He has made no secret that he seeks to make a living from posting anti-Scientology material on social media and monetising it - specialising in rage bait.

The Information Commissioner's Office concluded that Alex Barnes-Ross' conduct:

"appears to have been calculated to harass and offend."

(For the sake of clarity and brevity I have attached a few pieces of evidence of this).

An integral part of his strategy is using tabloid media that specialise in "sensationalism" feeding them embellished self-serving stories, and then pretending that he did not originate them. In the absence of a real story with any substance, he generates negative material himself – with misinformation and disinformation. What he does not simply make up, is highly selected or twisted

What is stated by Mr Barnes-Ross in the current application, aside from being misleading or untrue, is not relevant to the premises licence and can only be understood in the light of Mr Barnes-Ross' overriding agenda.

He states that he is only concerned about, and singles out, the IAS Event in October, much of which does not involve licensable activities. It is held in temporary marquees erected on a field behind Saint Hill Castle. Local neighbours on Saint Hill Road are the Sports Club, Rockwood Park and the Rugby Club. The remainder is fields and woodland. There are only six houses on Saint Hill Road which is three quarters of a mile long.

The IAS event is attended by several thousands of Scientologists, nearly 50 % of whom travel from abroad to attend. This creates a significantly large boost to the local economy. As mentioned, the long weekend event also features a charity concert which is also attended by more than a thousand non-Scientologists, and through which significant sums are raised for local charities and sports clubs.

Apart from a break during COVID, the IAS event has been held every year but one in the same field, with marquees, since 2005. It has always passed smoothly with no issues or incidents of any kind.

While outside of the scope of the Premises Licence, the only issues the Church has had to contend with have been those created by Mr Barnes-Ross and his small handful of associates.

For the past three years he has organised a protest, with a small handful of anti-Scientologists, outside the Church gates on Saint Hill Road to coincide with the three days of the IAS Event. This, and only this, has required the Church to request a police presence on the road. It has also required the Church to have to increase security substantially – particularly as several of the anti-Scientologists have previously trespassed on Church property, some have criminal backgrounds and, in the case of one, who had openly called for the assassination of the Church's leader and is the subject of a Court injunction for assaulting Scientologists.

With their presence right on the doorstep of the Church, holding anti-Scientology placards and shouting and chanting loudly the intent is evident. In 2023 Mr Barnes-Ross led a regular chant calling for the complete eradication of the Scientology religion. At any opportunity as Scientologists drove or walked past, they directly shouted at Scientologists on foot and through car windows while videoing and live streaming all their activities on the internet. Security at the gate had to be tightened, which slowed down the speed at which cars could enter. This created a temporary backup of vehicles on Saint Hill Road at certain peak times.

Mr Barnes-Ross and other anti-Scientologists standing on the verge of our property and at the main entrance gate meant Scientologists on foot had to walk in the road to avoid them. The cause of any "safety hazard" was the anti-Scientologists. We received many complaints from Scientologists about being harassed and feeling unsafe entering their own church. This is what happened in 2023.

Mr Barnes-Ross and associates shouted out the names of individual Scientologists while live streaming and posting this on the internet. YouTube has taken down more than a dozen of his videos for violating the safety and privacy of our members.

In order to protect Scientologists from being harassed and videoed while entering their church, in 2024 the Church asked the Council to grant a Public Spaces Protection Order (PSPO) – requiring the anti-Scientologists to hold their protest a little further down the road, away from the gate. The anti-Scientologists had refused to abide by police instructions to stand in an assigned location both in 2023 and again in 2024. The Council decided to monitor the situation in 2024, which resulted in somewhat better behaviour from the handful of anti-Scientologists – but they still refused to stay in a designated area and were still upsetting Scientologists arriving by foot. The extra security measures still meant some back up of traffic on Saint Hill Road at peak times.

Fortunately, the PSPO focused minds on resolving the issue, and the Highways Authority and the police agreed with us in principle to measures which would stop Scientologists being harassed at the gate. This was by creating a safe walk-way on the verge with a 6 ft high barrier. We also reorganised our traffic management and parking plan. All vehicles ingress through an entrance further down the road which led directly into the parking field. This allowed us to carry out security checks more on our property. The irony of this is that although Mr Barnes-Ross accuses us of not taking on board a suggestion of the Council to create another entrance for our members to avoid the protesters, when we did that this year, Mr Barnes-Ross moved his protest to that location which was also, further ironically, the exact location the police had designated for them over the prior two years which Mr Barnes-Ross was not satisfied with.

The combination of these measures meant that the purpose of the PSPO had been achieved. We appreciate the Council were, understandably, very reluctant to use such a measure unless absolutely necessary.

For the 2025 event we therefore were able to avoid congestion and to reduce the harassment of attendees by Mr Barnes-Ross and associated anti-Scientologists. From all reports from our attendees they felt the organisation of the event went off rather well and without a hitch.

In addressing Mr Barnes-Ross's individual points, which I do in the table below, it should be borne in mind that the three-day event he singles out only partially involves licensable activities. The Premises Licence is operating smoothly and well and that all of the licensing objectives are being met.

I have also included a Google Earth view of the area so it can be clearly seen as to what and where are the "local neighbours" in amongst the rolling fields. As a matter of standard procedure, a notice is delivered to all residents in the local vicinity days before the event that includes a dedicated phone number should anyone have any complaints or issues. We have never been called with complaints since 2014, when we engaged a new sound management company. Our local neighbours have written letters of support for the IAS Event and other events that we do because they are safe, friendly and are such benefit to the community.

I have endeavoured to deal with each of Mr Barnes-Ross' points in the table below. I have tried to do so as briefly as possible. I am happy to provide anything further that you may need. Mr Barnes-Ross seeks to create an illusion of problems where none exist. There have never been any issues with the licensable activities at Saint Hill in all of the years – despite the size of the many events that have taken place they have always been safe and well managed.

It is certainly our view that the Premises Licence in its present form is satisfactory and proper.

<p>A Freedom of Information Act request submitted to the Home Office revealed that in 2023, a total of 21 religious worker visas had been granted under sponsorship by the Premises Licence Holder (Appendices 03A and 03B). Legislation requires workers to be paid at least the minimum wage, which for a full time 40-hour work-week would have equated to £21,673 per annum. Staff at Saint Hill are members of Scientology's 'Sea Organisation' and sign one-billion-year contracts and are expected to work 7 days a week, often 14-16 hours a day with no time off. They are provided communal berthing, food and a weekly stipend of just £50 a week for their lifetime of service. Even if the holders of these visas were working just 40 hours per week, one would expect to see an increased expenditure on staff wages of £455,145 reflected in the Premises Licence Holder's annual accounts if they were being paid the National Minimum Wage.</p> <p>However, the 2023 accounts filed with Companies House (Appendix-04) show an increased expenditure of just \$294,860 AUD (£148,095 GBP) which suggests the workers at Saint Hill who have had their visas sponsored by Scientology are not being paid minimum wage, which is in breach of visa rules</p>	<p>As with the above, the allegation is wrong and misinformed.</p>

The media was generated by Mr Barnes-Ross himself, as described above.</p> <p>There were no noise complaints at all from local people – there are in fact only a small handful of properties on Saint Hill Road. During the festivities bagpipe music is played to welcome people, but not loud enough to bother any local residents and it is monitored by an independent sound management company that is retained every year for the IAS Event. If Mr Barnes-Ross had produced the actual report of the Independent Inquiry on Child Sexual Abuse on <i>Child protection in religious organisations and settings</i> you will see that the Inquiry, whilst very critical of circumstances found in other religious bodies, made no criticism of the Church of Scientology whatsoever.</p> <p>Moreover, Mr Barnes-Ross lies about the evidence given by the Church to the Inquiry. There was no admission of any instance of child sexual abuse within its UK premises. The Commissioner's position

13. The question for the Commissioner here is whether the complainant's request has the potential to cause a disproportionate or unjustified level of disruption, irritation or distress to the Council. In reaching a conclusion on this question the Commissioner has taken into account the reasoning of the Council, which in summary is that the complainant has pursued a campaign relating to the Council beyond a reasonable level, including that some of their actions have been inappropriate. The complainant argues that their request does have value and serious purpose.
14. Having reviewed the evidence provided by the Council, the Commissioner considers that some of the complainant's behaviour appears to have been calculated to harass and offend people involved with the Council. This includes merchandise that depicts individuals involved with the Council. This reduces the value of the serious cause the complainant may be pursuing.


"We are writing in support of the annual international gathering held at Saint Hill in East Grinstead, which has been a valued and established part of our community for decades.


